The 2013/2014 was a year of change for ACIP. In addition to developing and approving a new suite of operational policies and procedures, the Board and Executive Director adopted a new vision, mission, foundation, and areas of focus for ACIP's work. ACIP Activities 2013/2014

Advocacy & Public Policy.


In order to further injury prevention policy in Atlantic Canada, ACIP has initiated a series of policy analysis reports that briefly examine the evidence regarding a specific injury prevention policy and assesses the extent to which each of the Atlantic provinces have policies that are consistent with the evidence. This will not only inform ACIP's advocacy work; it will also support injury prevention partners throughout the region. The first report was released in February 2014 and focused on Graduated Driver Licensing (GDL) legislation. A second report on distracted driving has been developed and will be released early in 2014/2015. ACIP has collaborated with injury prevention stakeholders in Prince Edward Island and Nova Scotia to advocate for improvements to GDL legislation and will expand this work to New Brunswick and Newfoundland and Labrador, Other advocacy activities this past year have focused on helmet legislation and alcohol policy.

Surveillance & Research.

ACIP was engaged in two surveillance related initiatives in 2013/2014. First, ACIP continues to be the Atlantic collaborator for the Canadian Agricultural Injury Reporting (CAIR) program of the Canadian Agricultural Safety Association (CASA). Through this initiative, ACIP annually collects data on agricultural fatalities in the Atlantic region and partners with other collaborators and the Alberta Centre for Injury Control and Research to produce surveillance reports. Second, ACIP became part of a surveillance working aroup initiated by the Public Health Agency of Canada (PHAC) Atlantic office with membership from the four Atlantic Departments of Health. Throughout 2013/2014, this working group conducted a gap analysis of alcohol-related injury surveillance in the Atlantic region. A report of the findings is expected in early 2014/2015.

ACIP is an end-user member of the Strategic Team in Applied Injury Research led by Drs. Alison Macpherson (York University) and Ian Pike (University of BC). ACIP also continues to support several ongoing research initiatives and proposals for research funding.

With funding from the NS Department of Health and Wellness, ACIP produced a report of evidence on the impact of alcohol policy on sexual violence. The report was released in English and French in March 2014 and will contribute to ACIP's policy and advocacy work in 2014/2015.



Sustainability & Growth.

As noted on page 4, ACIP underwent a significant process of revising its vision and mission statements and adopting a new suite of policies and procedures. This effort is an important contribution to ACIP's long term growth and sustainability.

ACIP continues to have a successful funding relationship with the 4 Atlantic Departments of Health.

Networking, Partnerships, & Knowledge Exchange.

ACIP has networked and partnered with numerous organizations across Canada, including Parachute, a national injury prevention organization

In addition to being an active member of the Canadian Collaborating Centres on Injury Prevention, ACIP recently became the Chair of this community of practice.

ACIP was a member of the planning committee for the 2014 Canadian Injury Prevention & Safety Promotion Conference in Montreal.

ACIP continues to operate a website and listserv as a hub of injury prevention resources and news items.

Planning for the 2015 Atlantic Injury Prevention Conference is underway. The conference will be held June 8-9, 2015 in Halifax, Nova Scotia.
